

**NOTICE OF PUBLIC HEARINGS: THE PUBLISHED DISCUSSION  
DOCUMENT ON THE REGULATION OF INTERNET PROTOCOL TELEVISION  
(IPTV and VOD)**

The Independent Communications Authority of South Africa ("ICASA") hereby, in accordance with section 4(6) of the Electronic Communications Act ("ECA") No.36 of 2005, gives notice to convene oral hearings on the Published Discussion Document on the Regulation of Internet Protocol Television and Video on Demand (IPTV and VOD).

ICASA published the Discussion Document on the Regulations of Internet Protocol Television and Video on Demand (IPTV and VOD) on the 16 February 2010 General Notice 536, Government Gazette Number 32961. The Authority invited interested parties, stakeholders, and the public to respond to the issues raised in the Discussion Document. The closing date for the receipt of written representations was 26 March 2010. The Authority received seventeen submissions. Thirteen of these have indicated their wish to make oral presentations.


