
### NOTICE 129 OF 2011

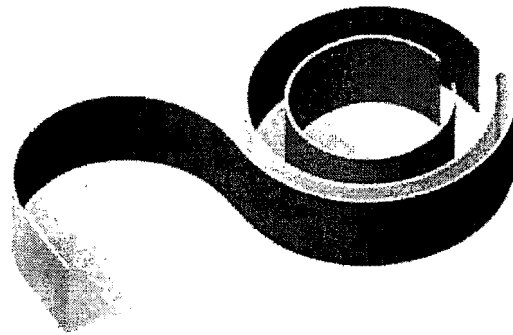

### **REQUEST FOR EXPRESSION OF INTEREST (EOI)**

Request for expression of interest issued by the National Consumer Commission in respect of the establishment of a registry in which any person may register a pre-emptive block for the purposes of restricting unwanted direct marketing.

#### **1.1 Purpose of the EOI**

The National Consumer Commission, (the NCC) an entity created in terms of Section 85 of the Consumer Protection Act 2008 (Act 68 of 2008) is in the process of identifying a Service Provider for the operation of an Opt-Out Register required by Section 11 of the Act .

The Act also provide that the Commission may establish ,or recognize as authoritative, a registry in which any person register a pre-emptive block, either generally or for specific purposes against any communication that is primarily for the purpose of direct marketing.

## **2.1 Background and Overview**

The National Consumer Commission is a juristic person established as an organ of state within the public administration but as an institution outside the public service in terms of the provisions of Section 85 of the Consumer Protection Act, 2008 (Act No 68 of 2008)

The Consumer Protection Act, 2008 mandates the Commission to establish a register which is reasonable and has effective means to receive, compile and utilize information relating to direct marketing.

The registry must cover and be accessible to all consumers within the Republic of South Africa and must promote the realization of each consumer's right to privacy.

The Commission has identified a need to call for expression of interest from any interested person or entity to assist it in establishing a recognized register as contemplated above.
